## WHAT DOES JERSEY CENTRAL FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  Social Security number and date of birth Account balances and activity Credit history and credit scores	
How?	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Jersey Central Federal Credit Union chooses to share; and whether you can limit this sharing.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account(s).
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  Jersey Central FCU does not have affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Nonaffiliates we share with can include insurance companies, government agencies, plastic card processors (credit/debit/ATM) financial statement publishers or printers, and others.</li> </ul>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	Jersey Central FCU doe snot share with joint marketers.
